Release, Waiver, Indemnification, Assumption of Risk, Covenant Not to Sue and Agreement to Hold Harmless

1. WHEREAS, in consideration of receiving permission to attend a course for Combined NRA Basic Pistol and Illinois Concealed Carry ("Activity"), for the use of any related premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Participant agrees to the following.

Participant hereby releases, waives, discharges, covenants not to sue and agrees to hold harmless and defend for any and all purposes Confident Concealed Carry and/or Alan Zielinski ("Instructor") and/or Michaelene George ("Range Safety Officer"), from any and all liabilities, claims, demands or injury including death that might be sustained by Participant while participating in the Activity or any related firearms activity or in any way related to the instruction received in this course.

Undersigned agrees to indemnify, hold harmless and defend Confident Concealed Carry and/or Alan Zielinski and/or Michaelene George from any and all latent defects in firearms or other equipment, fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with Participant's presence at and/or participation in the Activity; the discharge of firearms by Participant or any other person; Participant's presence on or use of the Instructor's material, building, land and premises ("Premises"); and, any and all acts or omissions of the Participant.

Participant furthermore waives for himself/herself and for his/her executors, personal representatives, administrators, assignees; heirs and next of kin; any and all rights and claims for damages, losses, demands and any other actions or claims whatsoever, which he/she may have or which may arise against the Instructor or Range Safety Officer, (including but not limited to the death of Participant and/or any and all injuries, damages or illnesses suffered by the Participant or Participant's property), which may, in anyway whatsoever, arise out of, be related to or be connected with: the Activity; the Premises, including any latent defect in the Premises; Participant's presence on or use of said Premises; Participant's property (whether or not entrusted to the Instructor and/or Range Safety Officer); and the discharge of firearms. Neither the Instructor nor Range Safety Officer shall be liable for, and Participant, on behalf of himself/herself and on behalf of his/her executors, personal representatives, administrators, assignees; heirs, and next of kin, expressly releases the Instructor and Range Safety Officer from any and all such claims and liabilities.

2. Assumption of Risks. Participation in the Activity as a participant or spectator carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The risks range from minor injuries to major injuries to catastrophic injuries including death.

Participant is also fully aware there are inherent risks involved with firearms and ammunition including but not limited to the following.

- Paralysis, injury or death while traveling to and from the activity site.
- Equipment may fail, malfunction or be used incorrectly by the Participant or others.
- Personal injury including but not limited to: strains, dislocations, torn muscles and/or ligaments; fractured or broken bones; eye damage; cuts, wounds, scrapes, abrasions and/or contusions; head, neck and/or spinal injuries; medical illnesses; allergic reaction, shock, paralysis or death

and serious injury or impairment to other aspects of Participant's body and general health and well-being. Participant nonetheless chooses to voluntarily participate in the Activity with full knowledge that the Activity may be hazardous to the Participant and Participant's property.

Participant has read the previous paragraphs and knows, understands and appreciates these and other risks that are inherent in the Activity. Participant hereby asserts that his/her participation in the Activity is voluntary and that Participant knowingly assumes all such risks.

Participant voluntarily assumes full responsibility for any risks of loss, property damage or personal injury including death that may be sustained as a result of participating in the Activity. Participant further agrees to indemnify and hold harmless the Instructor and/or Range Safety Officer for any loss, liability, damage or costs, including court costs and attorney's fees that may occur as a result of Participant's participation in the Activity.

3. Participant understands Confident Concealed Carry and/or Alan Zielinski and/or Michaelene George and/or the NRA do not maintain any insurance policy covering any circumstances arising from Participant's participation in the Activity or any event related to that participation. Therefore, Participant is aware he/she should review his/her personal insurance coverage prior to participating.
4. Participant gives permission for the Instructor and/or the Range Safety Officer to seek emergency medical, rescue or evacuation services should Participant become injured or ill with the understanding that Participant is solely responsible for any and all expenses incurred in doing so. Participant fully understands Confident Concealed Carry and/or Alan Zielinski and/or Michaelene George or any third parties do NOT provide any medical insurance coverage for Participant while participating in this Activity. Participant also realizes he/she may be attended to by the Instructor and/or Range Safety Officer on a best efforts basis until medical care is available if imminent peril is deemed to exist.
5. Participant acknowledges digital photographs and movies may be taken during the Activity and allows reproduction of those digital media to be used in promotional activities initiated by the Instructor. Participant hereby grants the Instructor the right and permission to copyright and/or use, reuse, publish and/or republish any digital media taken of the Participant during the Activity. Participant understands that he/she will have no control over the manner of use of the digital media and hereby waives any right to approve, reprove or inspect the materials prior to their distribution.
6. It is Participant's express intent this Covenant Not to Sue and Agreement to Hold Harmless shall bind the members of Participant's family and spouse, if Participant is alive, and Participant's heirs, assigns and personal representatives if Participant is deceased.
7. This release is governed by the laws of the State of Illinois and Participant expressly agrees this instrument is intended to be as broad and inclusive as permitted by law and if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedies by the Instructor and/or Range Safety Officer shall not constitute any waiver of Instructor's and/or Range Safety Officer's rights to pursue other available remedies. This instrument binds the Participant and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.

8. Participant understands as a critical aspect of his/her training, correction of the Participant's body placement and/or alignment may be necessary. Participant hereby authorizes the Instructor and/or the Range Safety Officer after providing appropriate verbal cues to appropriately place Instructor's and/or Range Safety Officer's hands as required on Participant's body in order to provide proper training including body and sight alignment. Participant also understands safety is the primary concern and authorizes immediate touching or movement of Participant's body to provide a safe environment for Participant, other trainees, range personnel and the Instructor and Range Safety Officer.

9. In signing this Covenant Not to Sue and Agreement to Hold Harmless, Participant acknowledges and represents that Participant has read the entire foregoing Covenant Not to Sue and Agreement to Hold Harmless agreement, completely understands it and signs it voluntarily as Participant's own free act and deed. No oral representations, statements, or inducements apart from the foregoing agreement that has been reduced to writing have been made. Participant executes this document for full, adequate and complete consideration fully intending to be bound by the same, now and in the future.

10. Participant furthermore acknowledges and agrees that he/she has read, understands and will at all times abide by all classroom and range rules and procedures as well as any other rules and procedures stated and/or posted by the Instructor and/or Range Safety Officer. Participant further acknowledges the Instructor reserves the right to refuse or terminate instruction to anyone for any reason without recourse of any manner.
